#### EVOLUTION OF INSTITUTIONAL LANDSCAPE

- The Fisheries Commission is established under the Fisheries Act, 2002 (Act 625). It is placed under the Ministry of Fisheries and Aquaculture Development
- It is legally mandated to manage and regulate the exploitation of the fisheries resources of Ghana
- The Monitoring, Control and Surveillance Division is charged with the monitoring, control, surveillance and enforcement activities in all fisheries waters.
- The Fisheries Act mandates the establishment of the Fisheries Enforcement Unit which comprises staff of the MCSD, Ghana Navy, Marine Police, Attorney General for the purpose of fisheries enforcement



### EVOLUTION OF LAWS AND REGULATIONS

- Fisheries Act, 2002 (Act 625)
- Fisheries Regulations, 2010 (L.I. 1968)
- Fisheries (Amendment) Act, 2014 (Act 880)
- Fisheries (Amendment) Regulation, 2015 (L.I. 2217)
- Other legislation related to Shipping, Maritime and Food
- The Fisheries Act, 2002 (Act 625) is currently under review



## **EVOLUTION OF AGENCY MANDATES/OPERATIONS**

- The Monitoring, Control and Surveillance
   Directorate works directly with the Fisheries
   Enforcement Unit to undertake fisheries
   enforcement activities.
- Sea Patrol and Boarding
- Port Inspections
- Beach Combing/Patrols
- Vessel Monitoring System
- Sensitization of Communities



### **EVOLUTION OF MCS OPERATIONAL CAPACITY**

- 64 personnel are working in the Fisheries Enforcement Unit in Tema and Takoradi (marine) and Kpando Torkor (Volta Lake)
- Operational Vehicles include pick-ups and buses
- Boats from the Ghana Navy and Marine Police
- Vessel Monitoring System and Automatic Identification
   System capabilities in Tema and Takoradi including 24/7
   monitoring shared with Ghana Navy, Marine Police, Ghana
   Air Force and Maritime Authority
- Electronic Monitoring System (utilizing closed-circuit video cameras) under the pilot Tuna Area Beyond National Jurisdiction Project (ABNJ)
- Prosecutions by Police and Attorney General Department



### UPDATE ON OTHER RELEVANT PROJECTS

- West African Regional Fisheries Project (WARFP) – Ghana (2012-2017). Component 2 is aimed at Reducing Illegal Fishing
- Sustainable Fisheries Management Project (SFMP) (2014-2019) is aimed at rebuilding pelagic stocks
- Area Beyond National Jurisdiction (ABNJ) –
  Ghana Tuna Project is aimed at improving
  management, combating illegal fishing, and
  protecting biodiversity in the tuna sector



#### Ratification and implementation of the PSMA

- Ghana ratified the PSMA in 2016
- Mandatory for Industrial vessels (foreign and domestic) to request to land
- The Fisheries Commission collaborates with the Ghana Ports and Harbours Authority and other Government Port Agencies in exercising Port State Controls
- The Fisheries Commission has trained fisheries inspectors for port inspections



### OVERVIEW OF MCS ACTIVITIES, OPERATIONS IN RELATION TO WATF

- Sharing of fishing licenses with the WATF
- Sharing of information on suspicious vessel in the sub-region and Ghana's EEZ
- Training of staff
- Technical exchange
- Verification of third party fishing licenses



#### STATUS OF NATIONAL WORKING GROUP AND AREAS OF COOPERATION

- National Working Group is structured around the Fisheries Enforcement Unit
- Organized meetings to strengthen inter-agency cooperation and collaboration
- Agencies collaborate in sharing information related to fisheries:
  - Fish importation
  - Vessel importation and registration
  - Vessel inspection
  - Fish safety



#### SUMMARY OF CASES IN RELATION TO WATF

- Liberia notified Ghana about a Ghanaian vessel in its waters. The vessel was not charged because of inadequate evidence.
- Hijacking of Ghanaian registered vessel by armed robbers with 45 Crew including 3 Korean officers, and one observer on board.
- Suspected double registration by two Ghanaian vessels, Lu Rong Yuan Yu 219 and 220



### UTILISATION OF INTELLIGENCE FOR MCS ACTIVITIES

- Intel on dual registration of vessels
- Intel of suspicious activities of reefers and trawlers in Ghana's EEZ
- Hijacking of Marine 711 in Ghana waters



### BENEFITS OF WATF TO MCS OPERATIONS

- Facilitated knowledge and information sharing
- Facilitated networking at the regional level
- Facilitated networking with international organizations
- Enhanced regional response to IUU issues



## ANY OTHER INFORMATION OF INTEREST / RELEVANCE

- Ongoing implementation of the National Marine Fisheries Management Plan
  - Implementation of Closed Seasons for artisanal and industrial fleet
  - Development of Marine Protected Areas
  - Co-management policy framework
- Launch of Study on Bio-degradable Fisheries Aggregation Devices (FADs)
- Fisheries Watch Volunteers assisting in the arrest and prosecution of fishermen
